# WHAT ARE THE NEW NATIONAL CRIMINAL BACKGROUND CHECK REGULATIONS?

- On January 10, 2013, Governor Patrick signed into law H. 4307, An act relative to background checks. The new law requires all public school employees in Massachusetts to submit to fingerprint-based state and national criminal background checks.
- School volunteers and subcontractors/laborers commissioned by schools to perform work on school grounds, may need to submit their fingerprints for subcontractors or laborers commissioned by schools to perform work on school grounds may be required to submit both a CORI check and fingerprintthe state national checks if asked to do so, and they must continue to submit to state CORI checks.
